**PRIVACY DISCLOSURE STATEMENT FOR MEMBERSHIP APPLICATION FORM**  
**('STATEMENT')**

[In this Privacy Disclosure Statement, 'CCS' means The Community Co-operative Store (Nuriootpa) Limited]

From 21 December 2001, CCS is required to comply with the National Privacy Principles ('NPPs') contained in the *Privacy Act 1988*. The NPPs set out minimum standards for the way in which organisations handle individuals' personal information. This Statement is provided in compliance with NPP 1.3.

CCS collects and holds personal information about you when you apply to become a member of CCS. The personal information collected is typically your name and contact details, your occupation and your employer's details.

CCS collects most of the information it requires directly from you on the 'Application for Membership' form. CCS may collect additional information from you by telephone, in person, by its representatives or by written correspondence from time to time.

CCS collects this information for the purpose of processing your application for membership and servicing you as a member. If you do not provide us with all of the information requested, we may not be able to process (and therefore may reject) your application for membership.

CCS may provide your personal information to its agents, contractors or service providers who act on CCS's behalf or who provide goods or services to CCS (for example delivery drivers). The identity of these agents, contractors and service providers may change from time to time.

We may also use your information to inform you about certain activities, goods and services of CCS or third parties, which we consider might be of interest to you. You may notify us at any time if you do not wish to receive this information by writing to our Privacy Officer at the address shown above.

You may seek access to the personal information held about you by CCS at any time (although some requests may be denied in certain circumstances). We will correct any information that we consider is inaccurate, incomplete or out of date.

Before providing us with any details about another individual, you must ensure that the individual is aware of:

- the proposed disclosure of their information to CCS and the purposes for which the information is collected by CCS; and
- the individual's ability to request access to the information held about them by CCS under the *Privacy Act 1988* (and to advise CCS if they think the information is inaccurate, incomplete or out-of-date).
